Juror and Judge: Annette Paquet is a Del Mar based artist with a fine arts degree from Pratt Institute. Annette is well known as both a *plein air* and studio painter. She currently teaches art at Mira Costa College.

Dates: Deadline for submission of digital images (jpeg) and postmarked entry forms with entry fees is Friday, March 9, 2012.

Submission of **digital images** is by email to ncsfa.entries@gmail.com.

Accepted entries for the Show will be notified on the website www.ncsfa.org on Monday March 20, 2012.

Load-in: Friday March 30, 2012 from 8:00am – 10:00am

Reception: Saturday April 21, 2012 from 12 noon – 2:00pm

Load-out: Tuesday, May 1, 2012 from 8:00am – 10am

Entry Fees: NCSFA members: 1 entry @ \$20, 2 entries @ \$25, 3 entries @ \$30

Non-members: 1 entry @ \$30, 2 entries @ \$35, 3 entries @ \$40

Prize money: Total prize money of \$1,025 will be awarded to 13 artworks: \$125 for Best in Show, \$100 for first place awards, \$75 for second place awards and \$50 for third place awards in each category.

NCSFA Prospectus Continued:

Categories: Four categories are planned dependent on the number of entries in each category. Some flexibility will be required to ensure even category sizes and prize money allocations. Therefore, artists please note that art media within the following four initial categories may need to be exchanged in consultation with the Juror.

Category 1: oil or acrylic on canvas or board

Category 2: watercolor including Chinese Brush painting

Category 3: pen & ink, pastel, collage, mixed media, prints

Category 4: photography, textile art, media with sculptural value.

Qualifications: Artwork must be original and suitable for family viewing. The artwork must not have been produced in class and not previously shown at PCPA. **Size:** Artwork must be not more than 4' by 4' in size. **Framing:** Glass on paintings is heavy and dangerous, therefore **plexiglass is required** for all paintings with the sole exception of pastel works. For wood frames, use screw eyes with opening of ¼" approx., positioned on the vertical sides of the frame, from 1 ½ to 2" from the top. Holes in the screw eyes should be parallel to the ceiling to accommodate the hanging wires available at PCPA. Hanging wire is not needed on the painting itself, but if already in place there is no need to remove. For metal frames, move the vertical side pieces to the top of the channel.

Commission: A commission of **15%**, submitted to NCSFA, is paid to the PCPA (City of Poway). The commission applies to all sales on entered works as well as cards, small matted or framed work sold at the Reception. One 6' table is available to the earliest arrivals wishing to take the opportunity of making sales on that occasion. For public viewing, submit short bios with contact phone number/s or email with accepted artwork.

Liability: Neither the North County Society of Fine Arts, nor its officers, agents or representatives, nor the Poway Center for the Performing Arts, nor the City of Poway assume any liability for damage, theft or loss of entered work. Artworks will be cared for, but insurance is the responsibility of the exhibiting artist.
